

How we rank the county's law firms

ompared with many other sectors, the UK legal profession does has not yet embraced realtime, consumer-driven, website rankings.

Currently, the closest equivalents are the widely-respected annual guide produced by Chambers & Partners and The Legal 500.

These independently-researched guides draw heavily on interviews with law firms' clients.

The Kent Legal Sector Review is based on the Chambers and Legal 500 rankings, which we translate into numerical scores.

We award five points for a top band ranking, four points for band two, and so on.

Where both guides analyse the same legal specialism a similar way, a total of 10 points up will be grabs in that section – five from The Legal 500 and another five from Chambers.

Where one guide covers a

specialism, but the other guide does not, the maximum possible score a firm can receive is five. Occasionally, we combine closely related sections.

For example, Chambers has multiple rankings covering corporate law advice, which we consolidated into one.

Where one legal directory consolidates previously separate rankings, but the other does not, we combine all of the rankings into one score.

In combined sections, we base our score on each firms' highest rankings

Our main findings are broken down into four broad tables; corporate and commercial; dispute resolution; private client and charities; and real estate and public sector.

The larger the firm, the more sections it will typically be ranked in.

Recognising that some Kent firms

enjoy a nationwide reputation, the main table of top firms across all disciplines adds firms' UK-wide Chambers rankings to their Kentspecific scores.

To give smaller or niche firms a chance to shine, the same table highlights firms that are highlyrated in four or fewer practice areas in Kent.

To allow readers to identify which of these firms are consistently highly rated, we produce an average score per ranking. We then rank firms from high to low, based on this average score. For most tables, last year's rankings are shown in parenthesis. However, because the legal directories change their Kent coverage on an annual basis, care should be exercised in drawing year-on-year comparisons. A substantial rise - or fall - in a



Cripps retains corporate dominance

Retaining its top spot once again,
the Tunbridge Wells firms ranks
comfortably in the lead with more
than double its competitors.
While it's score is slightly down on
last year, so are the majority of the

It dropped four points in the IT/ telecoms category and three in health and safety but still comfortably out guns the rest. Once again, as last year, its strength is being ranked by the two source directories across a number of disciplines.

It is, for example, one of just three in the list to be ranked for banking and finance; restructuring, insolvency and corporate recovery work; intellectual property; and media, entertainment and sport.

According to the Legal 500, it specialises in "private equity and M&A transactions in the healthcare, advertising, technology and media, insurance broking and education sectors" with its team acting for a "wide range of regional, national and international clients including



from the US, France and Spain". Elsewhere, it's very much a case of 'as you were' for the majority of firms in terms of overall rankings. West Kent-based Warners Solicitors edges up one place into fifth place, increasing its score over last year at the expense of Knights plc (formerly asb law) which drops a place. Girlings increased its score-fractionally - and Maidstone and Gravesend's Gullands falls off the table according to the latest rankings.

The biggest points gain was for Rix & Kay Solicitors, which has

The biggest points gain was for Rix & Kay Solicitors, which has branches in Ashford and Sevenoaks. Its three point rise was all courtesy of increasing its corporate work. It represents something of a bounce back as last year's rankings revealed it has lost two points in the same category. Very much a case of two steps back, three steps forward.

nyone hoping for a major surprise at the top of the list of Kent's best performing law firms are likely to be disappointed. Once again, there are a lot of very familiar names making the top 10 with only a little wriggle room.

Cripps Pemberton Greenish romp to its customary position at the top once again (even scoring the same amount of points as last year), while Thomson Snell & Passmore and Brachers take their customary positions right behind. There is, however, a slight change with Knights plc (which embraced asb law to its corporate bosom in March 2020) rising to pinch fourth place from Furley Page.

Worthy of particular note is Girlings' rise up through the ranks - leaping from 14th place last year to regain its top 10 place.

Slipping off the list are Brasted firm Sharratts and Gravesend's Stantons Solicitors

In their place, come Tuckers which enters at number nine in the list. Its Margate-based Kent Branch is the combined might of former firms Robin Murray & Co and Kent Defence which merged as part of the nation-wide leading criminal defence firm Tuckers Solicitors. Certainly it's been another challenging year for the law sector as firms adjusted to the 'new

normal' of home-working and the on-off nature of Covid restrictions.

Nationally, financial results suggest law firms did a good job of adapting to a world still haunted by the pandemic. The initial pessimism and concerns as the world locked down has been replaced with a rather more optimistic outlook

It has, if nothing else, demonstrated the flexibility of today's modern law firms to pivot when faced with what seemed like insurmountable challenges for a sector which thrives on face-to-face encounters and close collaboration.

According to PwC's annual survey of law 76% of the UK's top 100 law firms reported increased profits; a trend likely to be reflected on a more

Also worth noting, in the same survey, is that 48% of those same top ranked firms were expecting to reduce their office footprint in the short to medium term. It will certainly be interesting to see how that plays out in practice in Kent. There is, after all, a need, perhaps now more than ever, to be seen as a key member of the communities they serve - something which will surely slow any progress towards more online focused efforts.

No disputing the top firms



t's very much a case of 'as you were' in the dispute resolution category this year - with plenty of familiar names making up the list - the vast bulk of which occupy the same position as they did last year.

While Cripps Pemberton Greenish sit at the top of the tree, it does so with a hefty eight point drop on last year's score. Not that the gap between it and its nearest rivals has been greatly eroded as a consequence as many scores were down.

A seven-point dip was also seen by second-placed Brachers, which has offices in Maidstone and Canterbury, while six-points were shaved off Furley Page which once again occupies the third spot as too were they from Thomson Snell & Passmore.

Knights plc, which took over Maidstone's asb law in March 2020 following an £8.5m deal, is, however, notable by its absence this year after occupying fifth spot. Meanwhile, two new entries which made the list for the first time last year continue to retain a space in this year's countdown.

Margate's Boys & Maughan keeps its two points for its property and real estate litigation work, while Ashford's Rix & Kay Solicitors chalks up points for its commercial litigation work.

According to the Legal 500, Rix & Kay, alongside its core commercial dispute offering, holds specialisms in insolvency, restructuring and construction disputes, with clients including large SME businesses, professional services firms and accountants.



t's been an often challenging 12 months in the world of property - held back by the Covid restrictions, there has subsequently been a flurry of activity since lockdowns were eased and both private and commercial buyers and sellers started adjusting to the new normal. From businesses downsizing due to new hybrid working to the public sector re-examining their property portfolio in the light of a squeeze on funding while facing a raft of challenges they can barely have thought possible two years ago. It has been nothing if not eventful. Knights plc is the big

mover in this year's real estate and public sector table - catapulting its way to third in the list which it can put down to a significant point gain over the previous

12 months. It put on a remarkable 22 points lifting it up from 11th place last time out. In particular, has been its push into social

housing which saw it gain eight points alone. It is the only firm on this year's list to be ranked for the category. It also added five points through its work in the agriculture sector. The question is, can it build on its impressive showing to climb yet higher next year? The firm, which took over asb law, should not be confused with Knights Solicitors, based in Tunbridge Wells which is also on the list, albeit having shed several points in the category. Perhaps not surprisingly, Cripps Pemberton Greenish sit atop of the table once

again. According to

the Legal 500, Cripps

handles work for clients including institutional property investment companies, residential developers, local authorities, shopping centre owners and real estate lenders

But the gap between first and second continues to narrow. Tunbridge Wellsbased Thomson Snell & Passmore, which made gains last - albeit primarily through a change in the way the legal directories categorised the private sector (dropping separate categories to, instead, combine them) gained another six points on Cripps Brachers dropped into fourth, due to Knights plc's rise, while Rix & Kay continue to perform Dropping off the top

table this year is Brasted-based Sharratts and Margate's Boys Maughan.
